 - a. Advising Team Contacts (included in powerpoint)
 - i. They break the advisors up depending on their class standing; however, they can see anyone
 - ii. Drop-in advising from 10am-3pm
 - b. Common Questions
 - i. Self-Nomination-student applies directly
 - 1. This year they are not going to have winter application
 - a. This is to benefit the students due to the honors unit reductions
 - ii. Dropping Honors- survey that students fill out, but encourage the students to see an advisor first
 - iii. Benefits- advisors remind them of the benefits
 - 1. Smaller classes, study abroad, access to faculty, funding sources
